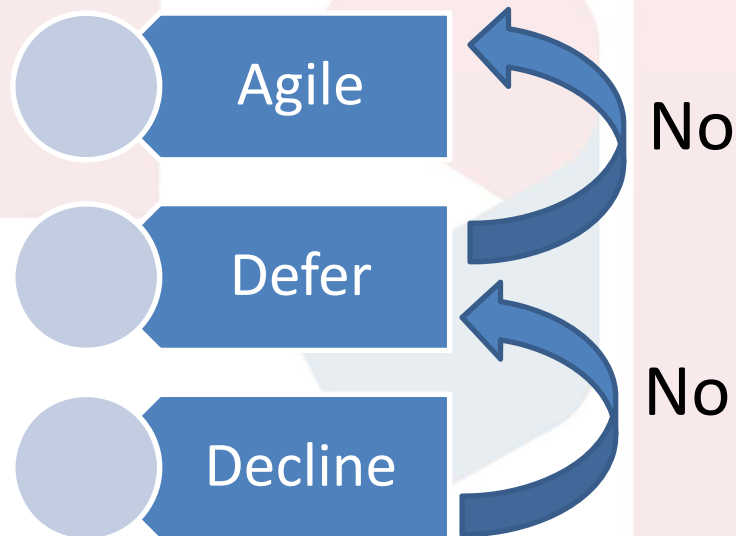

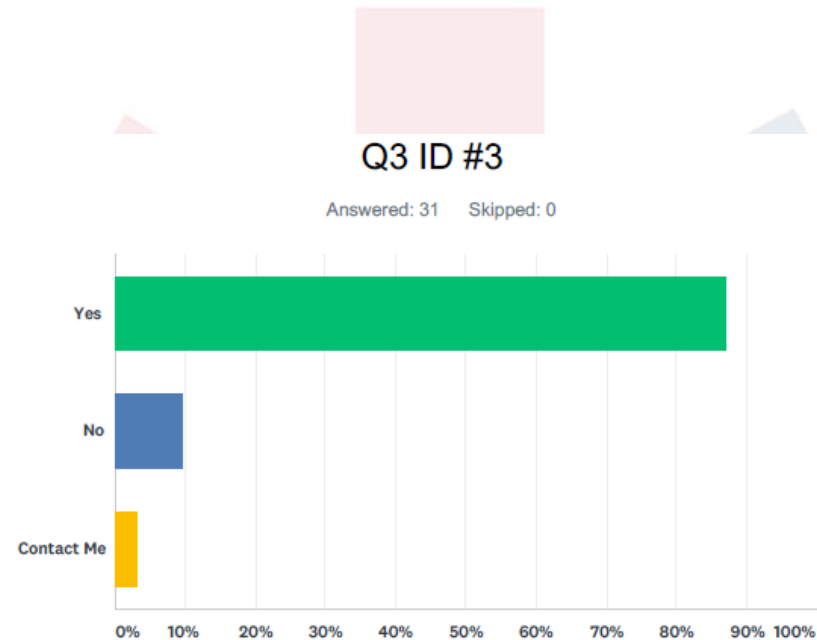
Melding Survey with Requests

 - I need more time to consider this!



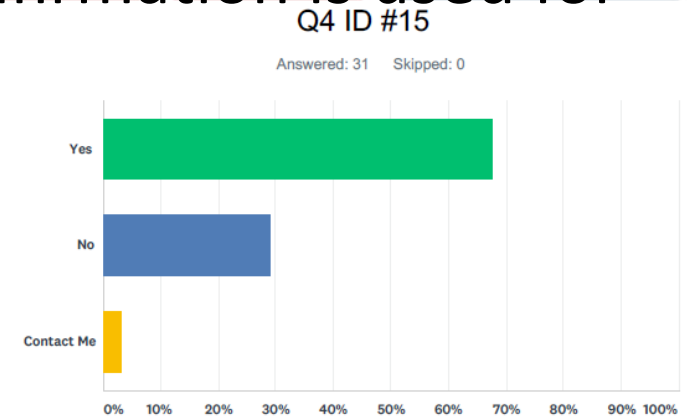
Decline: eArrest.03 (ID 3)

- eArrest.03 - Resuscitation Attempted By EMS
 - Change: Add value
 - Other



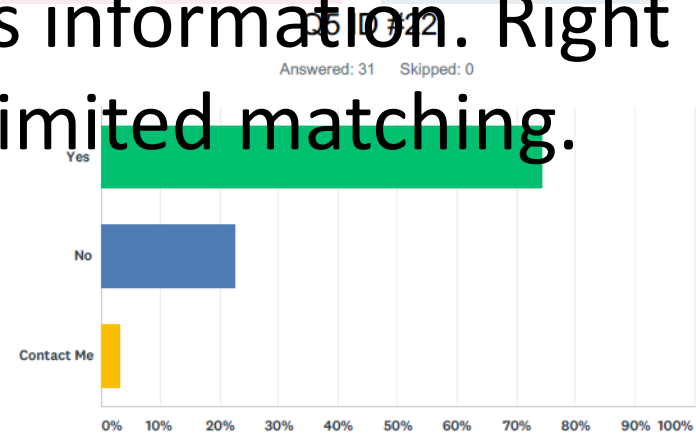
Decline: eAirway.04 (ID 15)

- eAirway.04 - Airway Device Placement Confirmed Method
 - Change: Add Value
 - X-Ray
 - Comment: This type of confirmation is used for pediatrics.



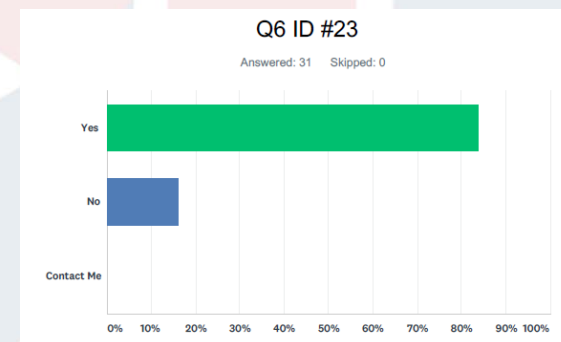
Decline: eScene (ID 22)

- **eScene.09** - Incident Location Type
- **Change:** Drop the use of ICD-10-CM
 - Create a standard list that is a subset of the NFIRS location type using the NFIRS
- **Comment:** Make it easier for fire based services to cross report this information. Right now, these lists have very limited matching.



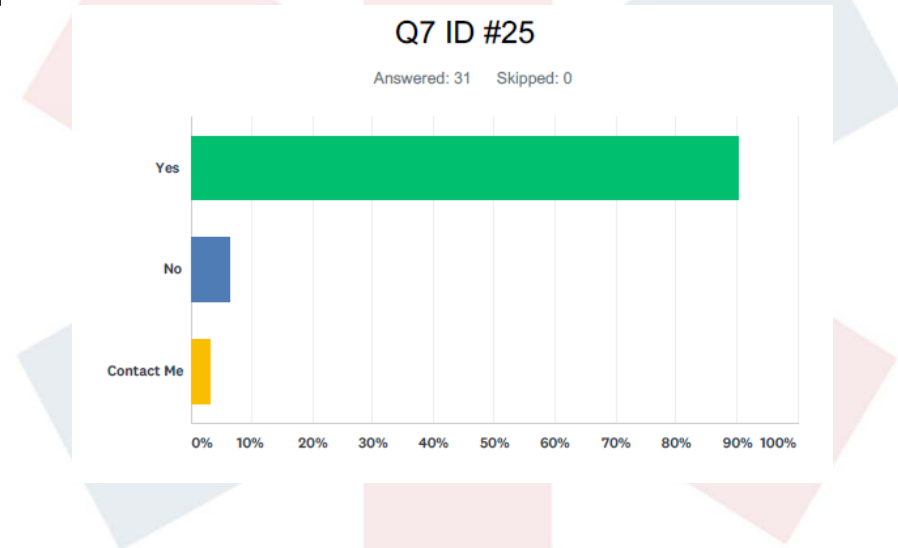
Decline: StateDataSet (ID 23)

- Additions to StateDataSet
- Change: Add Elements
 - eResponse.05 - Type of Service Requested
 - eResponse.07 - Primary Role of the Unit
 - eDisposition.16 - EMS Transport Method



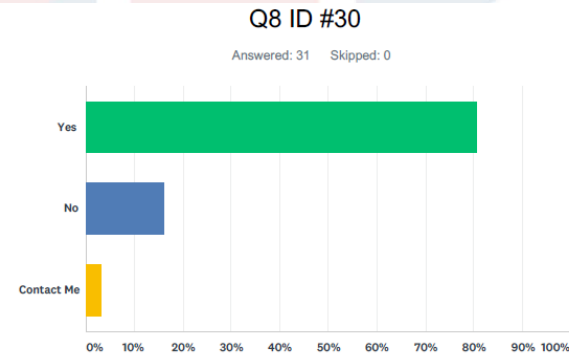
Decline: eArrest.16 (ID 25)

- eArrest.16 - Reason CPR/Resuscitation Discontinued
 - Change: Add value
 - Transferred patient care to other health care provider, CPR not discontinued



Decline: Pattern Change (ID 30)

- **Modify Patter for DataType: PhoneNumber**
- **Change:** Allow the digit "1" in the 4th position of a 10-digit phone number. This allows a phone number like 801-**1**23-6789.
- **Comment:** We adhere to NPA-NXX standard formatting, which does not allow for a "1".



Decline: eInjury.01 (ID 49)

- **eInjury.01 - Cause of Injury**

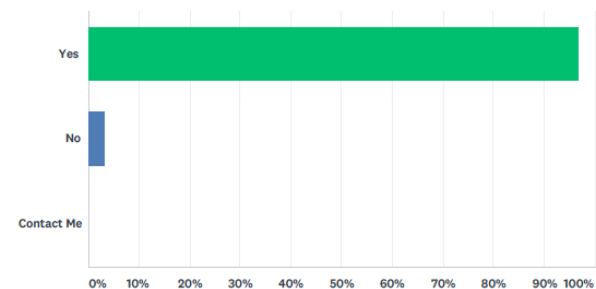
- Change: Pattern

- Change pattern to exclude Y93 codes, used in Patient Activity (eSituation.17)
- Current Pattern: `([TV-Y][0-9]{2})(\.[0-9A-Z]{1,7})?`
- Proposed Pattern: `??`

- Comment: Defined lists will address the concern.

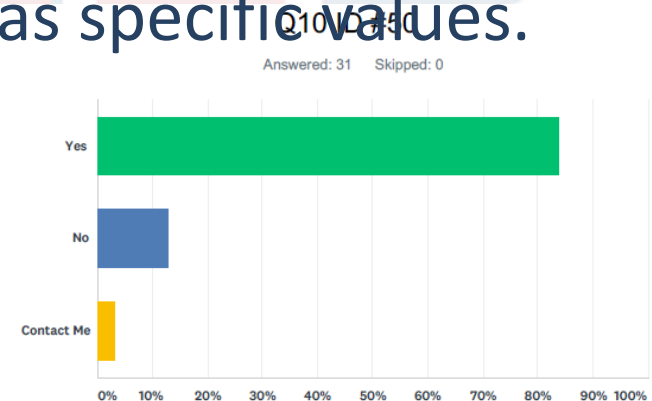
Decline: eExam.09 (ID 50)

- Change: Add values

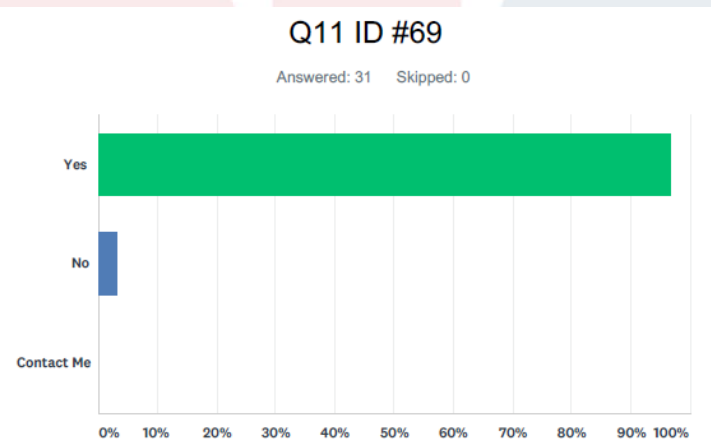
- S3 Gallop

 - Change: Add Attribute
 - TKO / KVO
 - Comment: There is a KVO option in eMedications.06.



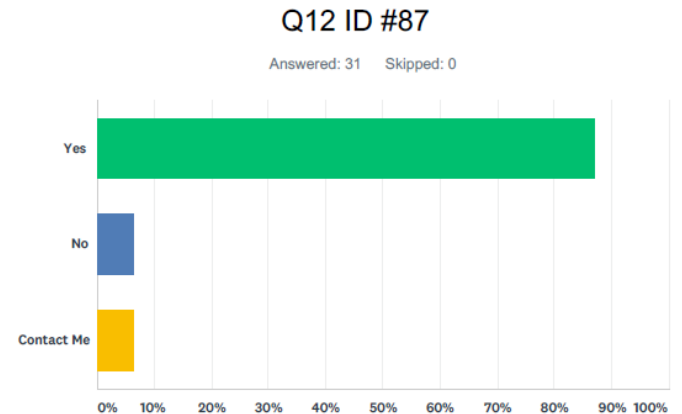
Decline: eSituation (ID 87)

- **eSituation.16** - Patient's Occupation

- Change: Add values

- Police
- Fire
- EMS
- 9-1-1 dispatch
- Corrections
- healthcare, etc.

- Comment: These high-risk professions are susceptible to suicide

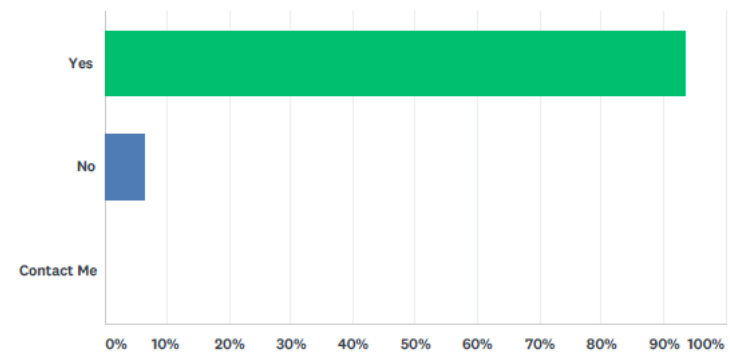


Decline: eResponse (ID 92)

 - Change: Add values
 - Ground Transport, Primary Care Provider
 - Ground Transport, Assist Lead EMS Agency
 - Comment: Would extend the meaning of this element.

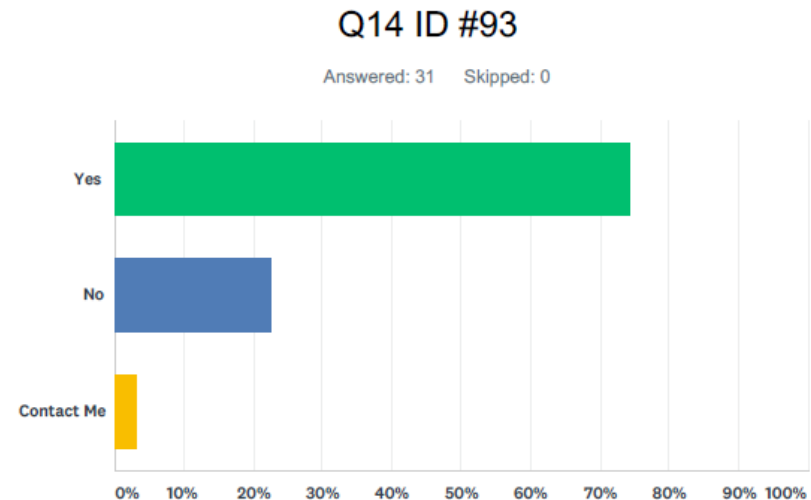

- Add NEW Element: Discontinued
- eDispatch.xx - Dispatch Narrative/Notes
 - Change: NEW Element Name:
 - Definition: Narrative or notes taken by the dispatcher or call taker.
 - Constraints
 - Data Type: String
 - minLength: 1
 - maxLength: 10,000



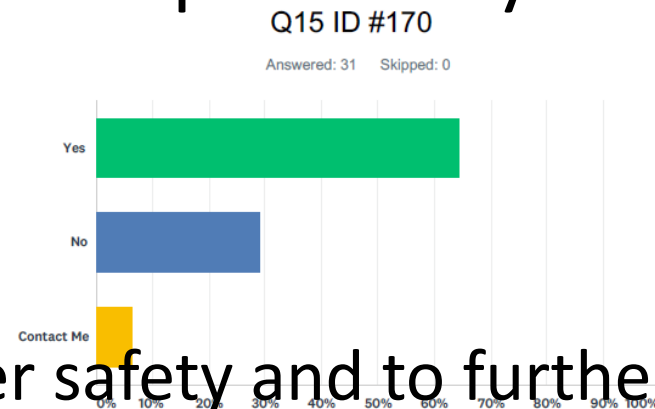
Decline: eResponse (ID 170)

- Change: Add values

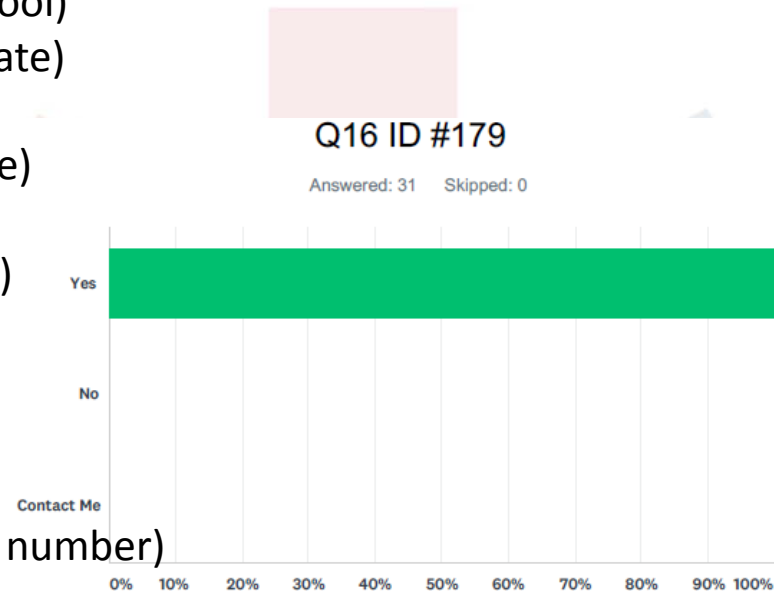
- Violent (patient)

 - EMSPersonnellsActive (yes/no or bool)
 - EMSPersonnellsTerminationDate (date)
 - SocialSecurityNumber (string)
 - StateIssuingDriversLicense (US State)
 - DriversLicenseNumber (string)
 - DriversLicenseExpirationDate (date)
 - EMSPersonnellsHairColor (string)
 - EMSPersonnellsEyeColor (string)
 - BodyWeightinKilograms (decimal)
 - HeightInCentimeters (decimal)
 - EmergencyContactNumber (phone number)

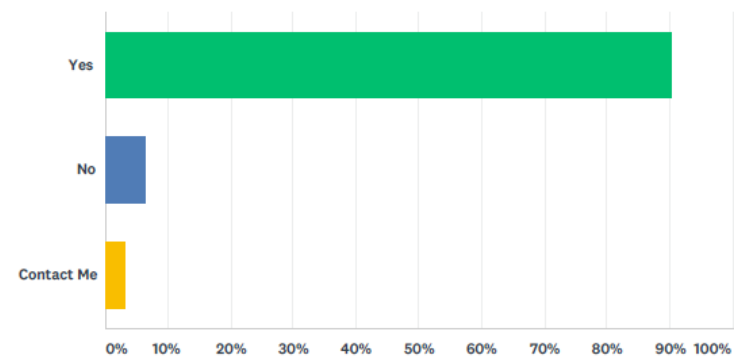

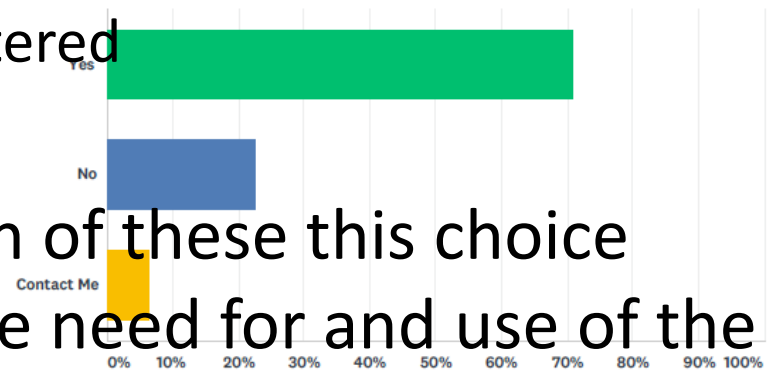
