Describing an EMS Event

- High level key descriptors of EMS events are intended to help service leaders, billers, state data managers, NEMSIS and other data stakeholders categorize and filter the events for more specific evaluation.
 - Once filtered and grouped the EMS events can be evaluated at a more detailed level using clinical and operational data in the record





Key Descriptors of EMS Events

- Type of Service Requested
 - Primarily 911 vs. Transfers
 - Other requests (e.g. Community Paramedicine)
- Role/equipment capabilities of responding unit
 - Non-Transport or Transport (Air or Ground)
 - Equipment available (ALS or BLS)
- Disposition of the incident





Describing Incident Disposition

- Was there a patient?
- If so, was the patient:
 - Treated?
 - By whom?
 - At what Level (ALS/BLS)?
- Was the patient transported?
 - By whom?
 - Who was in the transport vehicle?
- If the patient was either not treated, not transported or both- what else occurred?

Data Element Comment:

Values for "911 Response (Scene)", "Intercept" and "Mutual Aid" have been relabeled to start with "Emergency Response" to more easily identify these options. "Interfacility Transport" was relabeled to "Hospital-to Hospital Transfer" to be more accurate; options for "Sending Hospital Staff" and Critical or Specialty Care" were added to better track resource utilization at local and state levels and support reimbursement levels. "Medical Transport" was relabeled to "Other Medical Needs Transport" to cover any other medical transports such as transports to and from dialysis, doctor appointments, return home or nursing homes. Values added to consolidate types of service previously captured in "Primary Role of Unit" and "eDisposition.12" as found in V3.4. Additional values added to reflect emerging service types.



With the release of v3.5.0 values were added and relabeled to meet the needs of EMS.

Element relabeled from "Primary Role of Unit" to "Unit Transport and Equipment Capability" to better reflect its new defined purpose and allow the deprecation of eResponse.15 "Level of Care of This Unit". V3.4.0 Non-Transport values deprecated as these are types of service and were moved to eResponse.05 "Type of Service Requested". Values have been added to better capture transport capability and available equipment. These values should be tied to the capabilities and role of the unit and not reflect the level of providers responding to an event.

Data Element Comment:

The level of care should be defined by the situation, medications and procedures provided to the patient based on what is allowed in the local EMS protocols. This definition can vary between regions; what may be allowed for BLS providers in one region may be considered ALS care in another. This is not a reflection of the provider levels providing care, but the actual care given-for example, BLS care provided by a paramedic would be entered as "BLS". This element benefits reviews of performance, resource demand and utilization and reimbursement coding.

- Deprecate (remove/inactivate) eResponse.15 (Level of Care of This Unit)-element provided provider level and capability to NEMSIS for research but provides little utility to Agencies and States as they all have access to data from eCrew.02-Crew Level.
- The Equipment level can now be captured in eResonse.07 "Unit Service Capability"
- The level of care provided can now be collected in eDisposition.27 "Level of Care Provided per Protocol"

"Dead WITH Resuscitation Efforts (Black)" added for EMS units that arrived and provided resuscitation to a critical patient, but who was deceased at the end of the event (such as in a cardiac arrest).

- **Deprecate** (remove/inactivate) **eDisposition.12** (Incident/Patient Disposition) The element was used to capture too much information. Existing or new elements will clarify information related to the unit response, assessment, care, and transport of the patient.
- The information related to disposition of the incident/event response, patient care, and transport will be captured in three new elements:
- 1. [eDisposition.28] Patient Disposition
- 2. [eDisposition.29] Incident Disposition
- 3. [eDisposition.30] Transport Disposition

Data Element Comment:

This is the diagnosis or reason for transfer or medical transport provided by the ordering physician or medical provider. Hospital-to-hospital transfers and medical transports are based on the ordering medical provider, and not the EMS provider's impression. The text of the reason or diagnosis would be entered here rather than using the patient complaint field (as the patients may still have complaints to document), eSituation.11 "Provider's Primary Impression" or eSituation.12 "Provider's Secondary Impressions"

This element should only be documented when eResponse.05 - Type of Service Requested is (2205005) Hospital-to-Hospital Transfer, (2205015) Hospital-to-Hospital Transfer (with Sending Hospital Staff), (2205017) Hospital-to-Hospital Transfer (Critical or Specialty Care), (2205007) Other Medical Needs Transport, (2205029) Mobile Integrated Health Care Evaluation or Visit. 
