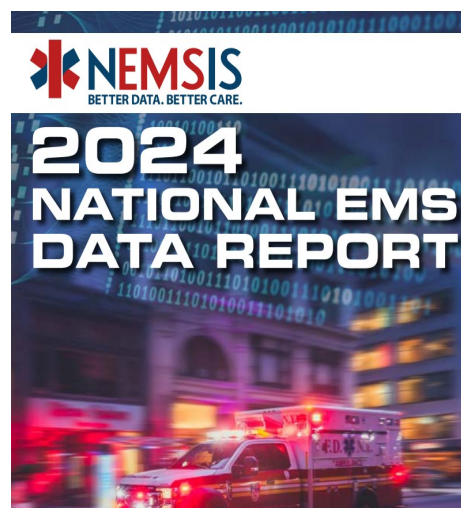
This report provides an overview of the key projects led by the NEMSIS Technical Assistance Center (TAC) during the past month.

NEMSIS National EMS Data Report

The NEMSIS TAC has published the 2024 National EMS Data Report. The report provides a comprehensive overview of EMS activations across the United States, representing a near-complete census of incidents from 97% of U.S. counties. With over 60 million EMS activations submitted by all 50 states, the District of Columbia, and three U.S. territories, the NEMSIS repository continues to serve as the nation's most robust source of prehospital medical care data.

We extend gratitude to the thousands of EMS clinicians, state and territory EMS offices, software vendors, and national partners whose dedication makes the EMS data collect possible. Your efforts ensure that EMS data can guide evidence-based care, shape policy, and improve patient outcomes nationwide.

NEMSIS Annual Meeting

The NEMSIS TAC extends gratitude to all NEMSIS stakeholders who were able to attend the 2025 Annual Meeting. The meeting was held August 26 - August 29, 2025, in Park City, Utah. One of the highlights of the meeting was the opportunity to celebrate and show appreciation to Dr. Greg Mears for his leadership in developing the NEMSIS standard.

We engaged 146 NEMSIS stakeholders representing EMS Data Managers, EMS Directors, Software Vendors, EMS and Fire Leadership, and other EMS professionals in discussions over several days regarding the future direction for EMS documentation and pre-hospital care delivery.

The TAC will carefully review the notes from the meeting to develop action items we will work on for the remainder of 2025 and in 2026.

NEMSIS Public Training

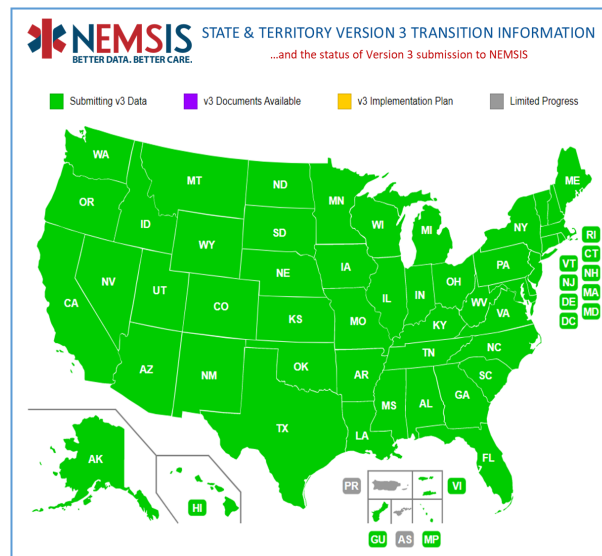

Participants learned how to download copies of the repositories, how different versions of the repositories are organized into branches, and how to look at the history of changes to each file. The repository contains the most up-to-date version of the data dictionaries, schemas, sample data, and state datasets. v3.4 and v3.5 Data Submission Summary

The NEMSIS TAC collaborates with State Data Managers and Software Vendors to ensure complete and timely data submissions to the national EMS database. Several States are currently submitting data using both the v3.4 and v3.5 data standards.

The counts listed below represent activity from January 1, 2025, through September 30, 2025. The information for unique ePCRs is based on Unit Notified By Dispatch Date/Time.

State submissions using the v3.4 standard were 1,500,032 records from 1,689 agencies.
State submissions using the v3.5 standard were 45,169,550 records from 13,867 agencies.

The reporting dashboards are all currently reflecting v3.4 and v3.5 data together. The national average failed submission rate for v3.4 and v3.5 data submissions is 0.92%.

v3 Data Use Agreements

We encourage State EMS Data Managers and Directors to continue efforts to execute the [NEMSIS v3.5 DUA](#).

The TAC works closely with the University of Utah's Office of Sponsored Projects (OSP) and the Privacy Compliance Office to review all legal modifications to the standard DUA. We are committed to working with officials in each state and territory to ensure that the DUA meets the needs of each respective state agency.
